These balances shall remain available for distribution to affected organizations until June 30,  $2008\ 2009$ , at which time any undistributed balances shall revert to the general fund, except that, in the case of organizations which have not filed an application to receive their appropriations by December 1,  $2006\ 2007$ , the Governor may direct that the undistributed balances be reverted to the general fund on that date. The Governor shall report amounts reverted and the affected organizations in the  $2007\ 2008$  Budget Bill.

D. The appropriation to those entities in this item that are marked with an asterisk (\*) shall not be subject to the matching requirements of § 4-5.05 of this act.

E. The distribution of a grant originally appropriated to Merchants Hope Church within Chapter 951 of the Acts of Assembly of 2005 shall not be contingent upon the

organization providing any source of matching funds as is normally required by §§ 2.2-1505 and 10.1-2213, Code of Virginia, or § 4-5.05 of this act.

F. Of the amounts appropriated to the Patrick County Music Association, up to \$25,000 shall not be subject to the matching requirements of § 4-5.05 of this act if used by the organization to pay for a study to locate a permanent home for the organization. Such study costs shall include site location and the development of cost estimates for the construction of a new facility or the renovation of an existing structure.

B. Supplemental funding for the regional health planning agencies shall be provided from the following sources:

1. Special funds amounting to one-half of the Certificate of Public Need (40608) application fees, which shall be distributed quarterly, plus any remaining funds from Certificate of Public Need application fees in excess of those required to operate the Certificate of Public Need Program.

2. General fund appropriations in Health Research, Planning and Coordination unexpended at the end of each year of the biennium shall be reappropriated for expenditure by the regional health planning agencies in the succeeding fiscal year.

3. The Department of Health shall revise annual agreements with the regional health planning agencies to require an annual independent financial audit to examine the use of state funds and the reasonableness of those expenditures.

C. Failure of any regional health planning agency to establish or sustain business operations shall cause funds to revert to the Central Office to support health planning and Certificate of Public Need functions.

D. The Commissioner of Health shall continue implementation of the "Five-Year Action Plan: Improving Access to Primary Health Care Services in Medically Underserved Areas and Populations of the Commonwealth." A minimum of \$150,000 the first year and \$150,000 the second year from the general fund shall be provided to the Virginia Office of Rural Health, as the state match for the federal Office of Rural Health Policy Grant. The Commissioner is authorized to contract for services to accomplish the plan.

E. Out of the Special Fund appropriation for this Item, \$278,000 the first year and \$278,000 the second year is appropriated from statewide indirect cost recoveries of this agency to match federal funds and support the programs of the Center for Quality Health Care Services and Consumer Protection. Amounts recovered in excess of these appropriations shall be deposited to the general fund.

F. In order to improve the training of certified nurse assistants in the Commonwealth, the Department of Health shall provide nursing facilities the maximum flexibility allowed by the U.S. Centers for Medicare and Medicaid Services regarding the provision of on-site training for certified nurse assistants. The Department shall allow facilities to provide such on-site training regardless of the enforcement status of the facility, so long as serious patient health and safety violations are not involved."

### **Explanation:**

(This amendment substitutes language contained in Item 290, Chapter 847, Acts of Assembly of 2007, which directs the Department of Health to provide regional health planning agencies with a portion of excess Certificate of Public Need (COPN) fees, after retaining balances in the fund equal to one month's operational costs in case of revenue shortfalls. A. Out of the amounts provided for the Virginia Water Facilities Revolving Fund, the

Department of Environmental Quality may transfer \$12,500 the first year and \$10,000 the second year to the Town of Tangier for a comprehensive plan to clean up waste and ash piles found on the island and implement systems to assure compliance with state environmental protection requirements.

B.1.*a.* Out of the amounts for Environmental Financial Assistance, \$200,000,000 the first year from the general fund shall be deposited in four equal quarterly installments to the Virginia Water Quality Improvement Fund established in Title 10.1, Chapter 21.1, Code of Virginia. Any unexpended balances on June 30, 2007 and June 30, 2008 from the amount appropriated in this subparagraph shall not revert to the general fund but shall be carried forward and reappropriated.

b. Included in this item is \$20,000,000 the second year from the general fund to be deposited to the Water Quality Improvement Fund established in Title 10.1, Chapter 21.1, Code of Virginia. Any unappropriated balances on June 30, 2008, from the amount appropriated in this subparagraph shall not revert to the general fund but shall be carried forward and reappropriated.

2. The amount amounts appropriated in subparagraph subparagraphs B.1.a. and b. shall be used solely to finance the costs of design and installation of biological nutrient removal facilities or other nutrient removal technology at publicly owned treatment works designated as significant dischargers for compliance with the effluent limitations for total nitrogen and total phosphorus, as required by the tributary strategy plans or applicable regulatory requirements. The Director of the Department of Environmental Quality is also authorized to make grants from the Virginia Water Quality Improvement Fund to private sewage treatment plants that are licensed by the State Corporation Commission as a public service corporation and that serve residential areas in the Shenandoah-Potomac River Basin with a design capacity greater than 4.0 million gallons per day.

C.1. Out of the amounts for Environmental Financial Assistance, \$17,000,000 the first year from the Water Quality Improvement Fund shall be provided as grants to local governments that are located outside the Chesapeake Bay watershed for: 1) the design and construction of mandated water quality improvement facilities at publicly owned treatment works for projects that would otherwise result in a financial hardship for the residential users of the facilities, based on the reasonable sewer cost-guidelines established by the State Water Control Board for the Virginia Water-Facilities Revolving Fund; 2) the correction of onsite sewage disposal problems; and 3) the development of comprehensive local and regional wastewater treatment plans,

preliminary engineering, and environmental reviews. The Department of Environmental Quality shall work with the Department of Housing and Community Development to develop appropriate criteria and guidelines for the use of this funding. Any unexpended balances on June 30, 2007 and June 30, 2008 from the amount appropriated in this paragraph shall not revert to the general fund but shall be carried forward and reappropriated. Out of the amounts for Environmental Financial Assistance, the Director of the Department of Planning and Budget shall transfer \$17,000,000 from the Water Quality Improvement Fund to the Department of Housing and Community Development for grants to local governments that are outside the Chesapeake Bay watershed.

2.*a.* Out of the amounts for Environmental Financial Assistance, \$12,800,000 the first year from the general fund shall be deposited to the Virginia Water Quality Improvement Fund established under the Virginia Water Quality Improvement Act of 1997. This appropriation meets the mandatory deposit requirements associated with fiscal year 2006 excess general fund revenue collections. Notwithstanding the provisions of § 10.1-2128, Code of Virginia, the Director of the Department of Environmental Quality is authorized to use these funds as grants to local governments that are located outside the Chesapeake Bay watershed.

b. Out of the amounts in this Item, \$1,613,700 the first year from the general fund shall be deposited to the Virginia Water Quality Improvement Fund established under the Virginia Water Quality Improvement Act of 1997. Of this amount, \$85,545 shall be deposited to the Virginia Water Quality Improvement Fund Reserve pursuant to Item 356 of this act.

shall be deposited to the Combined Sewer Overflow Matching Fund pursuant to § 62.1-241.12, Code of Virginia. From this Fund, the City of Richmond shall receive \$3,750,000 in the first year and \$3,050,000 in the second year and the City of Lynchburg shall receive \$3,050,000 in the second year.

Others listed in this item shall be administered under the provisions of § 4-5.05 of this act.

B. Prior to the distribution of any funds, the organization or entity shall make application to the department in a format prescribed by the department. The application shall state whether grant funds provided under this item will be used for purposes of operating support or capital outlay and shall include project and spending plans. Unless otherwise specified in this item, the matching share for grants funded from this item may be cash or in-kind contributions as requested by the nonstate organization in its application for state grant funds, but must be concurrent with the grant period. The department shall use applicable federal guidelines assessing the value and eligibility of in-kind contributions to be used as matching amounts.

C. Any balances not drawn down by recipient organizations on June 30,  $2007\ 2008$ , from appropriations in this item shall not revert to the general fund, but shall be carried forward on the books of the Comptroller. These balances shall remain available for distribution to affected organizations until June 30,  $2008\ 2009$ , at which time any undistributed balances shall revert to the general fund, except that, in the case of organizations which have not filed an application to receive their appropriations by December 1,  $2006\ 2007$ , the Governor may direct that the undistributed balances be reverted to the general fund on that date. The Governor shall report amounts reverted and the affected organizations in the  $2007\ 2008$  Budget Bill.
