Authority: Title 10.1, Chapters 11.1, 13 and 14; Title 44, Chapter 3.5; Title 46.2; §§ [46.2-1176](#) through [46.2-1187.3](#); and Title 62.1, Chapters 3.1, 20, 24 and 25, Code of Virginia.

A. The Department of Environmental Quality is hereby authorized to contract with the Virginia Institute of Marine Science for technical services to support a statewide comprehensive nontidal wetlands management program.

B. Included in the amounts for Environmental Resources Management is \$2,000,000 the first year from nongeneral

funds for the purpose of long-term maintenance of air quality and the correction and prevention of nonattainment status for National Ambient Air Quality Standards through air quality programs under the direction of the Director, pursuant to § [46.2-1182.2](#), Code of Virginia. These funds shall be used for air quality programs that impact Northern Virginia, to include air pollutant transport and air quality planning. The source of the nongeneral funds is the Vehicle Emissions Inspection Program Fund.
