Item C-204

A.1. This Item authorizes the capital projects listed below to be financed pursuant to Article X, Section 9 (d), Constitution of Virginia.

3. The total amount listed in this Item includes ~~\$125,532,000~~ \$196,932,000 in bond proceeds and ~~\$30,843,000~~ \$72,092,000 in higher education operating funds.
