Item C-76

A. The Virginia College Building Authority, pursuant to § [23.1-1200](#) et seq. of the Code of Virginia, is authorized to issue bonds in a principal amount not to exceed ~~\$62,312,208~~ *\$104,612,674* plus amounts needed to fund issuance costs, reserve funds, original issue discount, interest prior to and during the acquisition or construction and for one year after completion thereof, and other financing expenses, to finance the capital costs of the projects described in paragraph C. of this Item.

B. Debt service on bonds issued under the authorization in this Item shall be provided from appropriations to the Treasury Board.
