

Report of the Subcommittee on Transportation

(Senate Bill 800, As Introduced)

Senate Finance Committee Virginia General Assembly

February 7, 1999

## Mr. Chairmen:

The Transportation Subcommittee has been meeting over the course of the past year to consider the transportation policies of the Commonwealth.

The transportation policies we considered focused on two major issues: 1) funding for the Northern Virginia Transportation District Program and the Route 58 Corridor Development Fund; and 2) funding for major transit capital projects.

Funding for Northern Virginia and Route 58. Pursuant to passage of Senate Bill 1189, which authorizes \$104.3 million in new bonds for both the Route 58 Corridor Development Fund and the Northern Virginia Transportation District Fund, the subcommittee recommends using general funds to cover the anticipated debt service requirements in this biennium. Since it is projected that only one semiannual debt service payment will be needed for each program in FY 2000, and only about 60 percent of the projects will be ready for Northern Virginia, we are proposing additional appropriations of \$4.0 million GF for Route 58 and \$2.35 GF for Northern Virginia. It is our intent that appropriate funding sources to cover future annual debt service needs for these bonds will be proposed by the Governor and provided in subsequent appropriation acts.

Funding for Major Transit Capital Projects. Currently, it is very difficult to find sources of funding for major transit capital projects. Therefore, the subcommittee recommends that \$5.0 million in funds previously earmarked for a new transit performance incentive fund be diverted to the High Priority Transit Project Fund, pursuant to passage of SB 1256. These funds can be used to issue debt, match federal funds, or provide grants for major transit capital initiatives. In addition, the subcommittee is proposing to restore language inadvertently deleted last year that allows localities to designate secondary or urban road funds for transit projects. Also, the subcommittee is proposing to add language that would allow the Commonwealth Transportation Board to use primary highway construction district funds for major regional transit projects, at the request of the Metropolitan Planning Organization.

The subcommittee also recommends providing funds from a variety of transit-related sources for an expansion of the Greater Richmond Transit Companies' routes. We are also recommending an additional \$1.9 million for the proposed Norfolk-Virginia Beach transit system, contingent upon an affirmative local referendum.

Other Policy Considerations. For VDOT, the subcommittee recommends that priority consideration be given to providing road and rail industrial access funds in newly created Enterprise Zones serving economically-disadvantage areas.

For airports, we are recommending that the Secretary of Transportation and the Aviation Board identify funds to capitalize the Virginia Airports Revolving Fund, pursuant to passage of SB 1203.

For the Department of Motor Vehicles, we are recommending that license agents that electronically process and deliver their information be compensated at a greater level than those that continue to manually file information with DMV.

We hope, Mr. Chairmen, that it will be the pleasure of the Committee to adopt these and the other amendments in this report.
