REPORT OF THE SUBCOMMITTEE ON ECONOMIC DEVELOPMENT AND NATURAL RESOURCES

Mr. Chairmen and Members of the Committee:

I am pleased to report the recommendations of the Economic Development and Natural Resources Subcommittee. The subcommittee's goal was to focus limited resources on those items that promise the greatest return on investment as measured by more employment, greater economic prosperity, improved service delivery, and a cleaner natural environment. It was no small challenge to review and reconcile over \$500 million of budget amendments to the resources available.

ECONOMIC DEVELOPMENT

The subcommittee brings before you today a budget plan to strengthen Virginia's economy, through small business development, regional and local economic development projects, and technical and marketing assistance.

The subcommittee endorses the Governor's efforts to boost Virginia tourism. Tourism is an \$11.7 billion industry employing some 192,800 workers. The subcommittee is also supportive of the Governor's initiative for the Motion Picture Opportunity Fund, and honored the state's commitment to Virginia businesses through the Governor's workforce training amendment for the Virginia Employment Commission. Finally, the subcommittee applauds the Governor for his actions taken to continue the Opportunity Development Fund through the next biennium.

However, the most important issue addressed by the subcommittee this year concerns initiatives to spur economic development in rural Virginia. To that end, the subcommittee recommends additional funding for small business development centers and to sustain the A.L Philpott Manufacturing Extension Partnership. In addition to financial assistance, the subcommittee also recommends language amendments carried over from the 1999 Appropriation Act that will help direct spending in other economic development programs, such as the Shell Building Program and industrial development parks program.

To further promote regional economic vitality, the subcommittee proposes new spending for regional industrial parks and increased funding for Regional Competitiveness Act programs. The subcommittee realizes that the state's budget must reflect priorities beyond the missions of the agencies in economic development and natural resources. To that end, the spending plan recommended by the subcommittee is tempered by other committees' priorities, including funding for transportation, mental health and higher education.

The subcommittee's actions to reduce a portion of the proposed spending in SB 30 are targeted. The subcommittee's reductions reflect a general policy of phasing in new projects and refocusing the intent of initiatives.

NATURAL RESOURCES

For natural resources, the major issues facing the subcommittee are improving water quality, protecting the Commonwealth's open spaces, and preserving our state parks.

Concerning the Governor's proposal for cleaning state waters, the subcommittee elected to support the initiative with some modification.

The subcommittee recommends almost \$30.0 million to fulfill the objectives and requirements of the Water Quality Improvement Act. These moneys are from the general fund, interest earned by the Fund through January of this year, and other adjustments. The Water Quality Improvement Fund will not be used to support the on-going expenses of state agencies or to supplant general fund dollars.

However, the subcommittee recognizes the importance of most of the items designated for Water Quality Improvement Funds in the introduced Budget Bill. To that end, the Subcommittee recommends general fund dollars to match federal moneys for the James River Combined Sewer Overflow Projects, restore the proposed budget reductions in the Department of Conservation and Recreation, implement the poultry litter control program, and address the needs of the Soil and Water Conservation Districts.

Mr. Chairman, the subcommittee has long-recognized the importance of conserving open space. Equally as important, Mr. Chairman, should be our commitment to protect the livelihood of those Virginians who work the land and the state's waters.

To that end, the subcommittee proposes to further capitalize the Virginia Land Conservation Fund to promote the protection of farmland, open space, natural areas, and historic resources. The subcommittee also proposes language to ensure that the people who work the land have a voice in how these moneys are spent.

Lastly, the subcommittee recommends new spending for the Division of State Parks to properly operate and maintain the capital improvements made to the park system through the 1992 General Obligation Bonds.

The subcommittee is pleased with the amendments we offer here today, and we are confident that the work of protecting our environment and of promoting economic opportunity and development will remain important goals in Virginia. We believe that our budget recommendations will help meet those objectives. Respectfully submitted,
