# **REPORT OF THE SUBCOMMITTEE**

**on**

## **SPECIAL PROJECTS**

Mr. Chairmen and Members of the Committee:

The Special Projects Subcommittee reviewed 223 project requests totaling \$68.8 million for historic landmarks and nonstate agencies.

We recognize the value of these organizations to the Commonwealth. The investment of some state funds in these cultural attractions and educational organizations is a sound move to bolster economic development and education in Virginia.

Last year, you may recall that we did not provide any funding to these organizations in Fiscal Year 2002. Therefore, it was not surprising to see a record number of organizations approach us for funding during the short Session. Unfortunately, we are faced with limited resources available for these discretionary projects. Further, we are mindful of the needs in other areas and the funding required just to sustain ongoing commitments.

Therefore, we offer, for your consideration, increased funding of \$3.5 million above that in the introduced budget for historic landmarks and nonstate agencies in the second year. We ask the Committee to adopt our recommendations.
