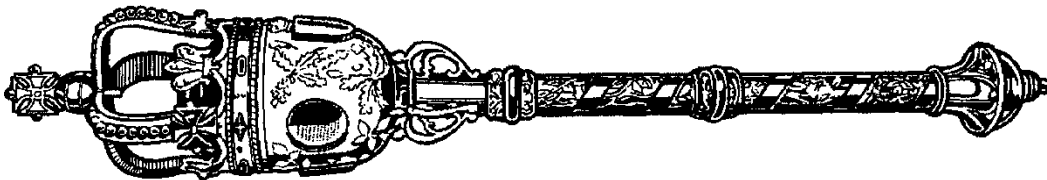

REPORT OF THE SUBCOMMITTEE
on
ELEMENTARY & SECONDARY EDUCATION

Mr. Chairmen and Members of the Committee:

As we have all heard this afternoon, this Committee has made many tough decisions this year. But once again, in a year of hard choices, the Committee has made public education one of its highest priorities. It is important to note that even with a now \$3.0 billion net reduction in House Bill 30, public education will receive a net increase of \$136.6 million over last biennium. Public education is one of only two areas of the budget that will receive a net increase in funding.

Because of this Committee's disciplined examination of spending, we have been able to meet our two highest goals in the Elementary and Secondary Subcommittee. First, we are proud to recommend \$38.0 million for the state's share of a 2.75 percent salary increase for teachers, effective December 1, 2003.

Mr. Chairmen, I want to take this opportunity to thank Delegate Tata and his Compensation and General Government Subcommittee for their dedication and help in working with us to achieve the savings necessary to fund the teacher salary increase.

The reduction in the Virginia Retirement System (VRS) rates will mean over \$56.4 million in reduced state costs for public education. And, at a time when our local governments are facing their own challenges to provide services, the resulting local savings will be very welcome.

In addition to the teacher salary increase, this Subcommittee is particularly proud of another achievement. Many of us had known for some time that the state should reexamine the minimum Standards of Quality to see if the standards reflected the true practices of school divisions. We were all shocked when the recent JLARC report noted that the state was not fully funding the current standards – the so called Tier 1 recommendations of the JLARC report. Despite this finding, and with few thinking there was any hope of fixing it, the Subcommittee was determined to begin addressing these basic deficiencies in SOQ funding. And, thanks to the hard work of our Committee, we are recommending over \$164.4 million be devoted to fixing the Tier 1 deficiencies cited in the JLARC report.

To accomplish the Committee's goals, reductions also had to be made in public education. Public education is over a third of the state's general fund budget, so it cannot be held harmless when reductions of \$3.0 billion are required. Of the reductions in public education, however, many were technical. For instance, \$77.4 mil-

lion was achieved when the teacher salary was removed in the first year, \$56.4 million was from the new VRS rates, \$54.6 million was from technical reductions such as inflation and anticipated balances, and \$48.9 million was achieved from removing add on programs already funded when the Standards of Quality was re-benchmarked.

Of the remaining decreases, \$131.9 million of incentive and discretionary programs were eliminated so that the Subcommittee could reprogram these funds into fixing the Standards of Quality funding.

In total, the reprogramming of these funds along with additional dollars has allowed the Subcommittee to cover \$114.8 million of the \$122.0 million Tier 1 deficiency in fiscal year 2004, or 94 percent.

I now would like for Committee staff to explain each of the Subcommittee's recommendations in more detail. I hope it will be the pleasure of the Committee to adopt our recommendations.
