REPORT OF THE SUBCOMMITTEE on HEALTH & HUMAN RESOURCES

Mr. Chairmen and Members on the Committee:

Many of you know that the work of the Subcommittee on Health and Human Resources is challenging even during robust economic times. The needs of Virginia's most vulnerable citizens are far greater than the resources we have to address them. But, in these times of economic retrenchment, the challenge to preserve the safety net of services for mentally and physically disabled persons, low-income children, and the frail elderly is even more difficult.

The declining revenue growth we are experiencing and the need to balance the budget have made it critical to ensure that we are spending every dollar wisely and that we can continue to serve those who are in greatest need for health and human services.

To that end, the Subcommittee had three goals:

- to preserve existing statewide programs and services that meet critical needs of our low-income children, the elderly, and disabled citizens;
- to defer program expansions and new commitments, which were not central to preserving the safety net; and
- to restore funding for core services that serve citizens throughout the Commonwealth and that make good sense both economically and from an humane point of view.

Due to the diligence and hard work of the Subcommittee, I know you will be pleased that the Subcommittee was able to preserve funding for health care for low-income children, families, frail elderly, and disabled persons. Almost \$664 million is provided through the Medicaid program to meet these needs. And, an additional \$2.2 million is available to meet enrollment growth projected in FAMIS, the children's health insurance program. The Subcommittee was also able to preserve \$38 million for children entitled to foster care and subsidized adoptions.

The introduced budget provided needed dollars to meet the rising costs of serving at-risk youth, entitled to care under the Comprehensive Services Act (CSA). However, upon closer scrutiny, we discovered that this new funding posed an additional burden to many of our localities by modifying the distribution formula which is based on local ability to pay measures. Localities would have been required to provide 50 percent of the costs to serve mandated children and adolescents. Currently, the localities pay a statewide average of 38 percent. Under this scenario, some rural localities would have experienced increased costs of up to 33 percent in this program.

We propose restoring \$18.8 million for the CSA program so localities don't experience a dramatic change in the current funding for this program over the next year. We are proposing a slight change to the funding formula in FY 2004 for supplemental funding localities receive through the program; however, the Subcommittee recognizes the need to work with localities over the next year to ensure that the funding formula is equitable and promotes the most efficient and effective use of federal, state, and local dollars. In total, we are recommending \$156.5 million to provide needed services for at-risk youth through the CSA program.

The Subcommittee was particularly concerned about the proposed across-the-board reductions of seven and eight percent over the next biennium. In total, these reductions would have cut \$73.5 million from health and human resources. As we looked at the numbers, we found that more than one-third of the reductions were directed at community-based services for mentally disabled persons.

For the past several years, the General has made sizeable financial commitments -- about \$133 million -- to build our community mental health, mental retardation and substance abuse services system and to provide high quality care for those in our state facilities. While we recognized that the current state of our revenues requires everyone to tighten their belts and become more efficient, balancing the budget by cutting services for our most vulnerable mentally disabled citizens just does not make sense.

Consequently, the Subcommittee took a number of steps to preserve funding for these essential services. First, we were able to provide \$35.5 million to fund all of Virginia's 5,536 slots for homeand community-based services for mentally retarded individuals. We were also able to preserve \$27.4 million to meet a projected shortfall in Medicaid funding for mentally retarded persons served in state facilities.

Through this Committee's help, we are able to provide \$16.6 million to mitigate the proposed across-the-board reductions for community-based and facility services for the mentally disabled over the next two years. In addition, we are proposing a plan to maximize federal reimbursement for community services which will stretch our state dollars. The end result of these efforts means that reductions to our Community Services Boards will total only 1.3 percent in each of the next two years. Finally, we propose restoring \$2.1 million this year to fully fund a projected shortfall in prescription drugs for mentally disabled citizens who are served in state facilities and Community Services Boards.

I think you will agree that these combined actions will preserve the gains we have made in improving the publicly-funded system of care for Virginia's mentally disabled citizens.

Mr. Chairman, as you know we have a number of very successful community programs that are aimed at strengthening our families and preventing the need for costly medical and social services in the future. Many of these programs use the money we provide to leverage funds from other private and public organizations.

The introduced budget attempted to preserve some of these programs replacing state dollars with federal welfare reform dollars. For others however, the programs would have to compete for a smaller pool of funding available through the welfare reform block grant. The Subcommittee was concerned that this strategy leaves some of our more successful programs vulnerable to competing demands for welfare funding, if our welfare caseloads begin to increase as our economy slows down. For others, a smaller pool of funding could have jeopardized the programs.

For this reason, the Subcommittee proposes restoring \$3.7 million in state funds and earmarking \$29.5 million in federal Temporary Assistance to Needy Families (TANF) funds for a variety of programs which fulfill the goals of welfare reform in Virginia. An additional pool of funding totaling \$24.1 million is available for discretionary state and community-based services on a competitive basis, should our welfare caseloads remain stable. By taking these actions, we were also able to leave a balance in our federal welfare reform block grant as a contingency in the event our welfare caseloads increase beyond current projections.

Mr. Chairman, this is probably the toughest Subcommittee assignment a member of this Committee can have. The decisions we make truly touch the lives of citizens who often do not have a voice, but have tremendous needs. I would like to thank the members of the Subcommittee for their hard work this Session, and I would like to thank the entire Committee for your efforts to mitigate the proposed reductions and preserve our safety net programs. The details of the Subcommittee's recommendations are contained in the attachments, and staff will walk you through them. Mr. Chairmen and fellow Committee members, we commend our recommendations to you for review and judgment. It is our hope that you will adopt our recommendations.

The State Board of Social Services shall adopt necessary regulations by which local boards of social services may request changes in their locality grouping, which is used to determine the amount of payment for the Temporary Assistance to Needy Families (TANF) program. Explanation:

(This amendment provides a mechanism that localities can use to request a change in the standards of assistance for calculating TANF benefits so that variations among similarly situated localities are minimized. The current standards have not been updated in more than 20 years. Currently localities are grouped into three categories for determining TANF assistance. Group I localities have an assistance standard of \$298 per month for a three-person household and include rural counties and small cities. Group II localities have an assistance standard of \$390 per month for a three-person household and consist of suburban counties and cities. Group III localities have an assistance standard of \$447 per month and include counties and cities in Northern Virginia. Changes in population and economic growth have made the three groupings problematic. For example, Spotsylvania and Stafford Counties are still included as Group I localities, while Virginia Beach is included as a Group II Waynesboro and Charlottesville are included as Group III localities. locality. Language is also added to limit the change to the TANF and Food Stamp programs and to allow the State Board to require that existing recipients be held harmless from benefit reductions.)
