### REPORT OF THE SUBCOMMITTEE on NATURAL RESOURCES

Mr. Chairman and Members of the Committee:

As we face increased budgetary pressures, it is evermore important that we strive to protect the vital natural resources of our Commonwealth, an area that continues to receive only one percent of our state budget. In fact, if we eliminated funding for the entire secretariat, the amount of general funds saved would represent about 15% of the revenue reduction that was reported by Governor Warner last Monday.

However, we do suggest several strategies to help restore some of the cuts proposed in House Bill 30. First, we recommend rejecting \$7.0 million in discretionary spending for Natural Resources that was proposed in House Bill 30. Second, we recommend authorizing the trading of some of our air quality credits, which is projected to generate \$6.0 million in new revenue. Third, we recommend targeted reductions totaling \$2.3 million.

By reducing the across-the-board reductions to all state agencies to 4 percent, we will restore \$2.8 million in general funds to Natural Resources agencies. In addition, we recommend restoring \$12.3 million in general fund support for state parks and \$1.0 million for marine patrol activities, which was eliminated in House Bill 30, as introduced. Finally we recommend restoring \$13.3 million to the Game Protection Fund, leaving the Department of Game and Inland Fisheries with adequate funding to avoid laying-off game wardens and having to sell the recent "Big Survey" acquisition.

Another area of interest is protection of our valuable water resources. In the good budget times, the Water Quality Improvement Act, passed by the General Assembly in 1997, has provided substantial new funding for water quality programs. In just five years, this legislation has brought about unprecedented efforts to control point and nonpoint source pollution of the lakes, rivers, streams and bays of our great Commonwealth. Based on the funding formula that relies on surplus revenues and state agency balances, there is no new funding for water quality initiatives. However, we do propose over \$2.1 million in interest earnings be applied toward the very successful agricultural best management practices program.

As part of our strategy to deal with these difficult financial times, we recommend maximizing the use of non-general funds to support environmental protection. Specifically, we recommend amendments that will allow fees for wetland permits and fines for violation of wetlands regulations to support the implementation of non-tidal wetlands legislation you approved during the 2001 Session. We also recommend amendments that allow more of the solid waste and water permit activities at the Department of Environmental Quality be borne by associated fee revenue.

Finally, toward our goal of protecting a million acres of openspace lands by 2007, we recommend to you language that will provide funding to the Virginia Land Conservation Foundation. We also recommend restoring funds to the Virginia Outdoors Foundation to assist in this goal.

Following the staff explanation of our amendments, we hope it will be the pleasure of the Committee to adopt our recommendations.

"Included in this appropriation is \$486,000 each year in nongeneral funds for the State Programmatic General Permit (SPGP) program. The source of the nongeneral funds is \$236,000 each year from fees associated with the program and \$250,000 each year from the Virginia Emergency Environmental Response Fund, representing fines collected as a result of wetlands regulation violations. In addition, the Department of Environmental Quality shall apply for federal grants, including a Coastal Zone Management Grant to ensure effective implementation and enforcement of Virginia's nontidal wetlands program.

The SPGP will allow DEQ to handle wetland permitting in an expedited manner, through a process that is simpler and quicker than any comparable federal regulatory program. DEQ has estimated that approximately 310 additional VWPP permit applications per year will be requested under the SPGP program. The source of the nongeneral funds is from fees paid for the permits. The amendment also requires that DEQ apply for federal funding to provide addition resources to implement the SPGP. In order to implement the SPGP, DEQ will need eight additional FTE's.)
