REPORT OF THE SUBCOMMITTEE on NATURAL RESOURCES

Mr. Chairman and Members of the Committee:

As we began our review of the funding proposed for Natural Resource agencies in the introduced budget, this Subcommittee was fully aware that expenditures within this area of government had been reduced by 45 percent since fiscal year 2001. We also were cognizant of the fact that our state's Constitution mandates that Virginia's natural resources be preserved for the enjoyment of its citizens. Consequently, this Subcommittee quickly and unanimously determined that, even in these most difficult times, protecting our natural resources is a core function of state government. Therefore, if at all possible, the Subcommittee was determined to at least maintain the existing level of funding for Virginia's natural resources. I am glad to report that we were more than able to meet this objective.

Mr. Chairman, I want to thank you and the other Subcommittees Chairmen for support of our efforts to improve the protection of Virginia's natural resources. Because of your support, and your commitment to avoiding further reductions within areas that had previously been cut, I am able to report to you today that not only were we able to maintain the existing level of funding for Natural Resources agencies, but we were are able to gain some lost ground by restoring some previous cuts to the State Parks and Soil and Water Conservation Districts.

Our first and foremost objective in crafting the Subcommittee's recommendations was to preserve the current level of funding provided to Natural Resources agencies. I am happy to report that the Subcommittee achieved this objective. Our recommendations will not result in the reduction of any Natural Resource agency's existing budget. At the same time however, we can not afford to move forward with any new initiatives.

In the area of water quality, the Subcommittee is recommending the deposit of \$7.7 million into the Water Quality Improvement Fund. This deposit, which is based upon the budget surplus generated in fiscal year 2003, will be used by the Departments of Environmental Quality and Conservation and Recreation to improve the health of Virginia's waterways. In particular, these dollars will be used to reduce the level of nutrients entering Virginia's waters by improving the operations of wastewater treatment plants and supporting the implementation of best management practices on agricultural land.

As I indicated, the Subcommittee was able to begin the process of restoring some of the cuts that were previously made to the Natural Resources agencies.

In 2001, our state parks were recognized as the best-managed state parks in the nation. In November 2002, nearly 70 percent of the voters approved a bond package to finance \$119.0 million in park improvements. Nevertheless, general fund support for our state parks has been significantly reduced over the past three years. If we are to maintain the excellence of our state parks system, we must begin restoring this general fund support. This Subcommittee is, therefore, recommending that \$1.0 million be used to restore 10 previously vacant positions in our existing 34 state parks and to offset some of the other reductions that have been made to state park operations.

In addition to restoring operating support, House Bill 29 includes approximately \$2.5 million for the state park system, representing the state's share of the clean-up costs incurred from Hurricane Isabel. These funds, which are included in the \$49.0 million statewide relief package, will be matched with 75 percent federal funding.

Another area the Subcommittee felt needed assistance is our local Soil and Water Conservation Districts. As you know, these unpaid but highly dedicated volunteers are our front line of defense in protecting the environment. Without our support, these local efforts cannot be as successful in protecting our state waters from sediment and nutrient pollution. Therefore, we are recommending the restoration of \$250,000 in general fund support for these programs.

Finally, I am happy to report this Subcommittee was able to recommend the restoration of the litter grants currently made to local governments. These grants support local litter control programs and coordinators. However, in the absence of this Subcommittee's actions, there would have been no money available for these grants in fiscal year 2005. To eliminate this problem, the Subcommittee is recommending that these grants be paid at the end of each fiscal year rather than at the beginning of each year. This policy shift will ensure that sufficient revenue is collected to make these payments in both the upcoming fiscal year and in future years.

Following the staff explanation of our amendments, we hope it will be the pleasure of the Committee to adopt our recommendations.

Page 300, line 19, strike "matching".

Page 300, line 22, after "fund.", insert:

"The amounts included for this purpose shall not be dependent upon the support provided to the Breaks Interstate Park by the Commonwealth of Kentucky."

Explanation:

(This amendment eliminates language that conditioned Virginia's support for the Breaks Interstate Park upon the total level of support provided by the Commonwealth of Kentucky. Currently, regardless of how much general fund support Virginia may provide to the Breaks Interstate Park, the park cannot use the full amount of that appropriation unless Kentucky contributes an equal or greater amount. Because Kentucky provided less support to the park than Virginia in both fiscal year 2003 and fiscal year 2004, the Breaks Interstate Park was required to return \$29,000 in support from Virginia each year.)

Explanation:

(This amendment provides for the restoration of Litter Control and Recycling Grants to localities in fiscal year 2005. Previously approved transfers had swept the funds necessary to make these local grants into the general fund. The language provides that these grants shall now be made each June based upon the revenue

collected between June of the previous fiscal year and May of the current fiscal year.)

(This amendment exempts capital projects under construction by the Department of Conservation and Recreation from the capital review and approval process managed by the Department of General Services' Bureau of Capital Outlay Management when those projects cost \$750,000 or less. The agency reports that nearly 60 percent of the projects authorized for construction using general obligation bond proceeds were valued at \$750,000 or less. The agency has stated that because these small projects must undergo the same process as multi-million dollar capital projects, review costs and DGS review fees greatly impact the scope of what the agency can build because those fees consume a larger portion of small projects' budgets.)
