2007 Report of the Economic Development and Natural Resources Subcommittee Walter A. Stosch, Chairman

Mr. Chairman and Members of the Committee:

I am pleased to report the recommendations of the Economic Development and Natural Resources Subcommittee. I believe that the amendments before you continue to honor the Committee's commitments in a fiscally responsible and prudent manner.

In *ECONOMIC DEVELOPMENT*, the Committee's amendments focus on strengthening Rural Virginia and encouraging new business development.

The Subcommittee endorses the Governor's actions to increase the workforce training program by \$4.0 million and the Enterprise Zone Program by another \$4.0 million. We also believe the Governor's \$1.0 million recommendation for the Southwest Virginia Technology Development Center will offer new economic opportunities in Coal Country.

The Subcommittee also agrees that an infusion of \$2.75 million for the Governor's Opportunity Fund is necessary and that development of a world-class research institute in the Shenandoah Valley will benefit all of Virginia.

In addition, the Subcommittee recommends greater investments in Rural Virginia. We bring to you amendments to do just that in tourism, small business finance, and housing.

Mr. Chairman, in the area of *NATURAL RESOURCES* the Subcommittee remains committed to our constitutional obligation. It is an obligation that the Committee has always taken seriously.

To that end, the Subcommittee's highest priority is improving water quality. We support the Governor's actions concerning the deposit of general fund surplus to Water Quality Improvement projects, funding for the James River CSO projects, and his recommendations for wetlands protection and solid waste management. The Subcommittee also includes amendments of \$1.7 million for DEQ to oversee the application of biosolids (sewer sludge). And, we support funding for Soil and Water Conservation Districts, increased water quality monitoring, and oyster replenishment.

The Subcommittee is also interested in protecting and preserving Virginia's historical resources and lands for recreational and economic purposes. The amendment package includes \$8.0 million for land conservation efforts and \$1.0 million to support Virginia's state parks.

In closing, I would like to say that we believe in Virginia's future, and we believe our recommendations will help make that future better.

"E. Out of the amounts in this Item shall be provided \$1 million in the second year from the general fund to support the development of workforce housing. Such housing units will be developed for members of Virginia's workforce with household incomes up to 150 percent of the area's median income and located in areas where prohibitive market conditions such as very high fair market housing costs, low vacancy rates and an imbalance between the creation of new jobs and new housing units make it difficult to access decent, safe and affordable housing. These funds will be used as capital subsidies to make workforce housing available and affordable in these markets and all units developed will continue to be available to such members of the workforce for a period of time as determined by the Department based on the level of subsidy. Maximum costs for such housing units will be determined by the Department. Priority will be given to housing development projects that take advantage of local affordable housing development incentives, employer investment for the benefit of its employees or have access to public transit. The Department shall report to the Chairmen of the Senate Finance and House Appropriations Committees by December 1 of each year on the use of the funds and the impact it has had on Virginia's housing needs."

Explanation:

(This amendment reduces by \$1.0 million the general fund deposit recommended by the Governor for the Virginia Housing Partnership Revolving Fund. In its place, the amendment establishes a pilot program to create new housing stock, rental units or homeownership opportunities, for persons in the workforce who cannot access affordable housing because of market conditions. Funds will be used as capital subsidies to reduce the debt on housing development and make it more affordable. Such subsidies could be in the form of interest rate reductions, low or no-interest loans or equity participation in a development.)

Page 106, after line 28, insert:

"Out of the appropriation for Community Development Services shall be included \$17,000,000 the first year transferred from the Water Quality Improvement Fund to be provided as grants to communities located outside the Chesapeake Bay watershed for: 1) the construction of mandated water quality improvement facilities at publicly owned treatment works for projects that would otherwise result in a financial hardship for the residential users of the facilities; 2) the design and construction of managed on-site community wastewater treatment systems in isolated areas that cannot be addressed through active treatment facilities; and 3) planning grants to develop regional or county wide wastewater treatment strategies in areas that have not previously completed planning and engineering studies. Priority will be given to the elimination of straight piping of household wastewater into the Commonwealth's waterways. The Department shall leverage the appropriation with other state moneys, federal grants or loans, local contributions, and private or nonprofit resources. Any unexpended balance in the item for this purpose on June 30, 2007, and June 30, 2008, shall not revert to the general fund but shall be carried forward, reappropriated, and allotted."

Explanation:

(This amendment directs the transfer of \$17.0 million in funding from the Water Quality Improvement Fund for a program to target communities outside the Chesapeake Bay drainage. The Department of Housing and Community Development will manage the program. Grants will be made to assist local governments in reducing the amount of untreated or under-treated household wastewater being directly discharged into streams and groundwater in non-Chesapeake Bay drainage areas. The Department of Housing and Community Development will use existing delivery systems to accelerate the commitment of these funds to community projects and document program impacts. A companion amendment is included in the appropriations for the Department of Environmental Quality.)

As part of the report, the Department shall identify the need for indoor plumbing program services by planning district commission; strategies for leveraging state dollars with resources from other public agencies, nonprofit organizations, and the private sector; options to reduce the cost to rehabilitate housing; and alternatives other than rehabilitation of existing structures. The Department shall submit the report to the Chairmen of the Senate Finance and House Appropriations Committees by December 1, 2007."

The Chairmen of the Senate Finance and House Appropriations Committees, or their designees from their respective committees, shall conduct a review of past economic arrangements made by the Commonwealth with Virginia-headquartered insurance companies. The objective of the review is to evaluate whether any arrangements made in such agreements have accomplished their intended purposes. The review may include recommendations to the respective standing committees for additional steps the Commonwealth may take to further the economic development goals underlying those arrangements. The Virginia Economic Development

Partnership and all other agencies, boards and commissions of the Commonwealth are requested to provide technical assistance, as required to the Chairmen or their designees in this review."

(This amendment directs the Senate Finance and House Appropriations Committees to evaluate economic development agreements between the Commonwealth and Virginia-headquartered insurance companies. The evaluations are to determine if the agreements' purposes were accomplished.)
