

Report of the Subcommittee on General Government

(Amendments to SB 750, as Introduced

Senate Finance Committee Virginia General Assembly

February 4, 2007

Mr. Chairman:

The General Government Subcommittee has met several times during the session to consider the two broad areas for which it has responsibility – General Government and Employee Compensation.

Let me briefly address our recommendations which, in keeping with the concept of making adjustments to the budget at the General Assembly's short session, are modest. Most of the \$20.0 million GF net increase we are recommending recognizes the cost of legislation that has been passed by the Senate:

- \$9.7 million GF is for the net cost of legislation,
- \$6.3 million is for jails and prosecutors,
- \$5.1 million GF supports targeted compensation increases to address critical problem areas, and

While we feel that all of these recommendations are necessary, a few of our recommendations are worthy of comment.

GENERAL GOVERNMENT

First, let me highlight some of the most important initiatives in the area of General Government, which include:

- \$2.4 million GF for nine new judges in the Circuit, General District and Juvenile and Domestic Relations District Courts.
- \$3.2 million to take another step toward completing the phasein of full funding for our Commonwealth's Attorneys. This continues to make progress on the promise we made in 2005, and
- \$3.1 million for the cost of maintaining inmates in local and regional jails.

Now, let me address compensation.

COMPENSATION

Last year, the General Assembly set aside funds for a 3.0 percent salary increase for state classified and state supported local employees. While we do not disagree with those who have said that more should be done, this year we have limited our recommendations to targeted compensation adjustments and the funding of legislation – much of which is significant:


- \$11.9 million to fund the increased Teacher Health Care Credit provided for in SB 1218.
- \$4.3 million to implement SB 1166, which increases the retirement benefits of State Police Officers beyond that provided in the budget, as introduced.
- \$3.9 million to provide an additional 3 percent salary increase for judges and an additional 5 percent for district court employees in FY 2008, and
- \$2.1 million to conform the post-retirement supplement for public safety officers covered under VALORS to the Social Security retirement age, as provided for in SB 1156.

Two of the compensation bills passed by the Senate have resulted in general fund savings of \$10.8 million:

- SB 1160 provides \$9.2 million NGF, which is the first stable funding source for the benefits provided under the Line of Duty Act for public safety officers or their families. This allowed us to use the general funds provided for this important program for other needs, and
- SB 977 increases the maximum retirement age for judges from 70 to 75, thereby saving \$1.6 million GF.

Mr. Chairman, we believe that our recommendations address the critical areas before us. It is our hope it will be your pleasure to adopt them.



- "2. In the event that counsel for a defendant who is convicted receives a waiver of the limitations on compensation, the court shall assess against the defendant, as a part of the costs of prosecution, an amount equal to the compensation limit specified in § 19.2-163, Code of Virginia, for each charge for which the defendant was convicted. If collected, such amount shall be paid to the Commonwealth.
- 3. Prior to the 2008 Session of the General Assembly, the Executive Secretary shall provide a report to the Chairmen of the Senate and House Courts of Justice Committees and to the Chairmen of the Senate Finance and House Appropriations Committees on: (i) the utilization of waivers; (ii) progress towards improved reporting of fee payments to court-appointed counsel on the basis of cases; and (iii) an updated comparison of Virginia's payments for court-appointed counsel with the level of payments of other states on a standard basis."

Explanation:

(This amendment makes several changes and clarifications in the language authorizing the Executive Secretary of the Supreme Court to waive the limit on compensation of court-appointed counsel. The Supreme Court will not be able to process electronic vouchers until 2008, so this amendment eliminates the requirement for court appointed counsel to submit waiver request vouchers via electronic voucher. In order to accommodate the additional workload created by the receipt of waiver

requests, the amendment authorizes the Executive Secretary to use up to \$150,000 to hire additional staff to process waiver requests. Current law requires convicted defendants to reimburse the Commonwealth for any costs incurred by the state for court-appointed attorneys, up to the limit set out in statute. This amendment continues this requirement for those convicted defendants whose attorneys receive waivers. This amendment also permits the Executive Secretary to use up to \$350,000 for improved financial management and reporting systems, and requires a report prior to the 2008 Session of the General Assembly.)

Effective July 1, 2007 all deputy sheriffs employed by a locally elected sheriff, shall be provided with those retirement benefits provided for under §51.1-138 B, Code of Virginia, with or without the resolution of election required therein, provided however that the retirement benefit for such employees shall be based on a service multiplier of 1.70.
- 2. Effective July 1, 2007 the retirement benefit for all locally elected sheriffs shall be based on a service multiplier of 2.00; and upon reaching age 55, an increase in the retirement multiplier equal to 0.025% for each year of service beyond age 55, and an increase in the retirement multiplier equal to 0.025% for each year of creditable service beyond 25 years of creditable service".
- 3. Effective January 1, 2008 localities may opt to provide a retirement annuity for their local public safety officers as defined in §51.1-138 B, Code of Virginia based on a) a service multiplier of 2.00; and b) if so electing, may also elect to provide an additional increase in the retirement multiplier upon reaching age 55, equal to 0.025% for each year of service beyond age 55, and an increase in the retirement multiplier equal to 0.025% for each year of creditable service beyond 25 years of creditable service.

The treasury loan shall be repaid for these costs from the funds collected for localities through the federal debt setoff program.
- 4. The Department of Taxation shall submit a request to the 2008 General Assembly for a special fund appropriation to reflect projected on-going operational expenses to administer the federal debt setoff program."
