# REPORT OF THE SUBCOMMITTEE ON PUBLIC SAFETY

On Senate Bill 750, as Introduced  
(February 4, 2007)

## Mr. Chairman and Members of the Committee:

Your subcommittee has reviewed the provisions of Senate Bill 750, the budget bill as introduced, with respect to the Office of Public Safety. This has been a relatively quiet year for this area, with only minor modifications to the budget.

We support the Governor's proposed salary increase for adult and juvenile correctional officers. Over the past four years the turnover rate among correctional officers has increased from 14 to over 19 percent, and this step will help to restore the competitiveness of state salaries for these positions.

We support the Governor's proposed All-Hazards Initiative, with minor modifications, to strengthen our emergency preparedness capabilities in several agencies.

We recommend certain modifications in the Governor's proposed Re-entry Initiative, reducing the proposed funding for new grants for pilot local re-entry councils, and increasing funding for evaluation research to determine which programs are most effective in reducing offender recidivism.

We recommend adding \$2.5 million to support Victim-Witness programs. Non-general fund support has leveled off in recent years, and these programs will begin to experience a significant shortfall next year unless we provide general fund support.

We recommend \$900,000 for expanded mental health treatment in the nine local or regional juvenile detention centers that currently receive no state support, but we also intend that these funds should be used to increase services, not to supplant existing local funds.

In 1979 the General Assembly created a new program of state aid to localities with police departments, as part of the compromise that year which was intended to resolve the long-standing issue of annexation. The funding formula, which was set forth in House Bill 599 of 1979, is primarily driven by population growth. This formula is essentially unchanged since 1979.

We recommend that the hold harmless provision which we put in place for this year, fiscal year 2007, be extended to next year, fiscal year 2008. Then, we recommend that all of the growth in the program for fiscal year 2008 (\$8.3 million, less a new allocation for the Town of Windsor) be distributed according to the existing formula. This approach will provide these localities with a stable source of state aid for next year and beyond. A spreadsheet with the distribution of funds is attached for your review.

Your subcommittee appreciates your continuing support as we move forward to meet our responsibilities for public safety.

Mr. Chairman, this completes the report of your subcommittee.
