REPORT OF THE SUBCOMMITTEE on HIGHER EDUCATION

Mr. Chairman and Members of the Committee:

On behalf of the Higher Education Subcommittee, I offer budget recommendations that address our common priority of making higher education affordable.

Mr. Chairman, last year we made a historic investment in higher education by providing nearly \$550 million in new general funds representing an increase of over 16 percent, the second highest increase in state support nationally. In fact, Virginia's percentage increase in state support over the last ten years is seventh nationally. In terms of our funding guidelines, colleges and universities are now at 99 percent of their base funding requirements, with many institutions in excess of 100 percent. When one considers that only three years ago our higher education system was about 85 percent of its calculated funding need with many institutions below 80 percent, the progress we have made is phenomenal.

Unfortunately, this has not translated into a level of affordability that this Subcommittee expected when it recommended increased general funds. At the request of college and university presidents, the tuition cap was lifted in 2002 and since that time our institutions have increased tuition and fees for undergraduate Virginians by more than 90 percent. In fact, just last year when the Commonwealth was providing record increases in state support, the colleges and universities were increasing tuition and fees by nearly 10 percent, or more than 40 percent greater than they indicated they would do in their six-year financial plans. Virginia ranked among the top ten highest states in terms of tuition and fee increases. Mr. Chairman, this is simply unacceptable.

So, in order to assist those in-state students that are affected by these increases, the Subcommittee recommends \$9.5 million in general funds for need-based undergraduate student financial aid. This represents a 10 percent increase, on top of the 13 percent increase we provided last year. This will bring undergraduate financial aid to about \$105 million annually. In addition, the Subcommittee has recommended an additional \$2.5 million for the Tuition Assistance Grant (TAG) program. The additional funding will increase the annualized TAG award for undergraduate students to \$3,250 by the second year of the biennium.

Finally, we are pleased that the Chairman has agreed to earmark \$38.3 million from the revenue reserve for two higher education purposes. First, we have recommended \$34.0 million to create a Tuition Moderation Incentive Fund. Since providing general funds directly to colleges has not led to affordability, perhaps this approach will yield better results. The Fund provides general fund allocations to public colleges and universities provided that tuition and fee increases for in-state undergraduates are no more than 2.25 percent above the level needed to pay for faculty and staff salary increases. We expect that average tuition and fee increases will be about 5 percent. Let me be clear, this is not mandatory nor is it a tuition cap. Institutions have a choice; their Boards of Visitors can set tuition and fees to levels that they deem necessary. However, we recommend that the Commonwealth focus its limited resources to encourage institutions to keep increases reasonable.

The remaining \$4.3 million in the revenue reserve is set aside for an additional one percent increase for teaching and research faculty.

Mr. Chairman, details of our Subcommittee recommendations are attached, and I hope that it will be the pleasure of the Committee to adopt them.

- "3. a. Out of this appropriation, the Director, Department of Planning and Budget shall transfer \$1,000,000 the second year from the general fund to the University of Virginia to support cancer research.
- b. 1. Out of this appropriation, \$1,500,000 the second year from the general fund is designated for the Virginia Coastal Energy Research Consortium (VCERC) to implement research and development of Virginia's marine renewable energy resources, with an initial focus on offshore winds, waves, and marine biomass. These funding amounts are necessary for (but not limited to) energy resource assessment, characterization of extreme storm survival conditions and sea floor anchoring and foundation properties, identification of potential environmental concerns, new technology research and development to enable project installations in deeper offshore waters "over the horizon," and realistic evaluation of economic benefits and new business opportunities for Virginia's maritime industry. These funds also are necessary to support VCERC's close engagement of the Mineral

Management Service (MMS) to ensure that the new MMS rules for alternative energy uses of the outer continental shelf, as well as the 2007-2012 offshore leasing program now being formulated, are well-supported by data and have the best possible terms for Virginia.

The distribution of funds to VCERC member institutions shall be as follows:

The above funds shall be used to support the following VCERC activities:

- 1) Characterization of offshore wind environment and extreme wave and current conditions and sea floor anchoring and foundation properties (ODU and VT-ARI).
- 2) Estimate of economic benefits and identification of workforce training and entrepreneurial development needs to support a marine renewable energy industry in Tidewater region (ODU, NSU, and industry partner)
- 3) GIS development to map other uses of Virginia's outer continental shelf, including military, shipping, and commercial fishing, and identify areas with minimal potential conflict (ODU and JMU).
- 4) GIS development to map flyways of migratory shore birds, pelagic birds, and potential storm impacts on migratory patterns, as well as baseline assessment of offshore benthic communities (VT, VIMS and JMU)
- 5) Assessment of potential environmental effects of commercial offshore wind power development (ODU and VIMS)
- 6) Engineering studies of innovative technology for deep-water moorings and platforms, integration of hybrid project concepts, and long-distance submarine power cable transmission (VT-ARI and Industry Partner)
- 7) Engagement with MMS rulemaking and leasing program development for Virginia's outer continental shelf, to ensure favorable regulatory environment and promote federal revenue sharing with state (VT-ARI)

- 8) Investigation of potential offshore solar energy applications (NSU)
- 9) Independent validation of emerging technology innovations that minimize ocean space requirements for offshore wind energy (JMU, VT-ARI and Industry Partner)
- 10) Extension of existing undergraduate curriculum in renewable energy to include coastal energy topics (JMU)
- 11) Measurement program and pre-feasibility study of wave-powered desalination application to recharge coastal aquifers threatened by sea level rise (VT-ARI and ODU)
- 12) Literature review and preliminary planning to conduct long-term research on marine biomass as a source of liquid and/or gaseous fuels (ODU and JMU)
- 13) Assessment of the VT Agricultural Extension and research Center as an anchor and field laboratory for VCERC studies related to the nearby access to deepwater and offshore research projects.
- 2. Out of this appropriation, \$500,000 the second year from the general fund is designated for cost-sharing on proposals submitted in response to federal R&D funding opportunities from the Department of Energy, the National Science Foundation, and other federal agencies. These cost-sharing funds shall be allocated by the VCERC Board of Directors on a competitive basis, and only proposals involving at least three VCERC institutions working together shall be eligible for such cost-sharing. ODU will fund the support for the VCERC organization as required and provide industry sub-contracting as appropriate to support research and industry collaboration.
- 3. It is intended that VCERC shall operate following the administrative model of the Virginia Space Grant Consortium, employing Old Dominion Research Foundation as its fiscal agent.
- 4. Funding contained in b.1. and b.2. is contingent on the Virginia Coastal Energy Research Consortium (VCERC) and / or the member institutions being able to document existing financial investments in such research activities of at least \$2,000,000 from other federal or private funds.
- c. Out of this appropriation, the Director, Department of Planning and Budget shall

\$1,000,000 the first year from the general fund to the State Council of Higher Education for Virginia in support of research efforts related to House Bill 2238.

d. Out of this appropriation, \$1,000,000 the first year from the general fund is designated for the Commonwealth Technology Research Fund pursuant to \$2.2-2233.1., Code of Virginia. These funds shall be used primarily to enhance the capability of institutions of higher education to commercialize technologies developed through their research. Specifically, these funds shall support collaborative, translational research aimed at commercialization of discoveries, including pre-investment funding to support prototyping and proof-of-concept testing. Awards from the Fund shall be matched on at least a dollar-for-dollar basis by the respective institutions of higher education with institutional funds, private funds, local funds or combinations thereof."

- B. Upon certification by the Governor that the general fund revenue estimates referenced in subparagraph A have been met for the fiscal year ending June 30, 2007 and upon certification by the Governor on October 1, 2007 that the general fund revenue estimates referenced in subparagraph A for the fiscal year ending June 30,

- C. Upon certification that the requirements have been met in subparagraph B., \$4,300,000 shall be used to provide the general fund share of an additional one percent salary increase for full-time and part-time teaching and research faculty and graduate teaching assistants at public colleges and universities effective November 25, 2007. This increase is addition to the increase already provided in item 461 of this act.
- D. Eligibility for allocations listed in subparagraph B. of this item shall be made only to those institutions who limit in-state undergraduate tuition and fee increases in fiscal year 2008 to no more than 2.25 percent above the level calculated as required for the nongeneral fund share of state-approved salary increases and which are listed in subparagraph B. The State Council of Higher Education for Virginia (SCHEV), in consultation with staff from the Senate Finance and House Appropriations Committees, shall determine whether each public college and university has met the

tuition requirements of this fund. SCHEV shall report its findings to the Governor and Chairman of the Senate Finance and House Appropriations Committees by August 15, 2007.
