# REPORT OF THE SUBCOMMITTEE ON CAPITAL OUTLAY

# On Senate Bill 800, as Introduced (February 6, 2011)

#### Mr. Chairman:

As you are aware, the General Assembly has authorized over \$2.5 billion in general fund supported capital projects since 2008. Until the beginning of this session, most of us believed that most -- if not all -- of the more than \$1.0 billion in projects authorized last year would need to wait years before construction could begin. The changes in the definition of the Commonwealth's debt capacity that have been adopted by the Governor should allow many of these projects to move forward in the next year.


With that as background, we felt that it is prudent to allow some of the backlog of projects to begin construction before authorizing more. There are, however, a number of actions that still require approval by the Finance Committee and we recommend them to you in this report. These actions fall into three broad categories:

- 1. \$525.2 million for new construction and renovation projects to be funded from Virginia Public Building Authority and Virginia College Building Authority bond proceeds. Among these are:
  - Renovation of the historic Rotunda at the University of Virginia, and
  - Long overdue renovation and construction of key buildings at the seat of government, in Richmond.
- 2. \$4.0 million general fund for preplanning of 15 capital projects, including the top 10 priorities of the Virginia Community College system.
- 3. \$284.1 million for nongeneral fund supported projects, mostly at institutions of higher education.

We are aware that many of you are interested in specific capital projects. As is the practice since adoption of the capital outlay process reforms in 2008, specific amounts for each project are not shown. This allows us to receive the most competitive bids from contractors. However, a detailed spreadsheet is available for your review.

Mr. Chairman, we believe that our recommended amendments set out a sound approach for the Commonwealth's capital program. It is our hope it will be your pleasure to adopt them.



The transit system extends along, and adjacent to, the entire southern boundary of the university's campus. As part of the consideration and in exchange, and at no additional cost to the Commonwealth, the university is authorized to acquire from the City of Norfolk fee simple title to certain properties now comprising the McDemmond Center's improved parking lot, located at the southeast corner of the intersection of Reservoir and Claiborne Avenues, as well as various remnant parcels as described in the agreement, including parcels containing 1.373, 0.198, and 0.124 acres, more or less, and a parcel comprised of a narrow strip of land lying, in part, between the rail line corridor and the university's Ballentine parking lot, all primarily to serve the parking and open space needs of the university. Prior to acceptance thereof, assurances to the satisfaction of the Governor, or his designee, shall be obtained through an environmental study indicating the properties to be acquired are free from hazardous materials and conditions."
