REPORT OF THE SUBCOMMITTEE ON PUBLIC SAFETY On Senate Bills 29 and 30, as Introduced (February 19, 2012)

Mr. Chairman and Members of the Committee:

Your subcommittee has reviewed the provisions of Senate Bills 29 and 30, the budget bills, as introduced, for the Office of Public Safety and the Office of Veterans Affairs and Homeland Security. These two secretariats were separated last year.

In the budget as introduced, the combined FY 2014 appropriations for these two secretariats are only 1.4 percent higher than the comparable amounts for FY 2007 – seven years earlier. During these years, we have experienced sharp reductions in general fund resources, and more recently, a slow increase. As a result, we have had to make difficult choices, set priorities, and streamline operations. This year, your subcommittee's recommendations are very modest, resulting in a spending reduction of \$1.3 million when compared to the budget as introduced. This amount is available for other priorities of the committee.

The Office of Public Safety has experienced significant downsizing over the past four years. You are very familiar with the closure of adult and juvenile correctional facilities, and the reductions and elimination of programs in the various agencies. The introduced budget includes the closure of Mecklenburg Correctional Center, which is another setback to the economy of Southside Virginia. For this reason, we are recommending \$1.3 million each year to restore payments in lieu of taxes or service charges to help the localities in this region.

Our top priority in recent years has been to strengthen Virginia's efforts to help our veterans, especially our Wounded Warriors returning home from Iraq and Afghanistan. A decade ago, the Department of Veterans Services was a far smaller agency. Over the seven-year period from 2007 to 2014, the DVS general fund budget will have more than doubled.

In the budget as introduced, we support the new initiative in cooperation with the Department of Medical Assistance Services to identify Virginia veterans receiving Medicaid who may instead qualify for federal Veterans Administration disability and medical benefits. This should result in a savings to the Commonwealth. We have worked closely with your Subcommittee on Health and Human Resources to review this initiative. We have also recommended an additional \$150,000 each year for the automated veterans claims processing system and \$140,000 each year to strengthen the internal management of the agency, during this period of rapid growth. For the Department of State Police, we are committed to eliminating the delays experienced in the computerized background checks of individuals purchasing firearms. For this reason, we recommend adding just over \$400,000 each year and five more positions to staff this program.

Your subcommittee recommends \$6.2 million for the required deposit to the Corrections Special Reserve Fund, based on the sentencing bills adopted by the Senate that affect the future need for correctional facility bedspace. The introduced budget included a \$12.1 million deposit, so our amendments provide a savings of \$5.9 million, when compared to the introduced budget.

We also recommend that \$6.0 million from the Corrections Special Reserve Fund be allocated for the highest priority security-related capital improvement project for the Department of Corrections, which is the replacement and repair of security systems, doors and locks at Marion Correctional Treatment Center in Southwest Virginia. We have provided this recommendation to your Capital Outlay Subcommittee for its consideration.

We have worked very closely with your General Government Subcommittee to ensure that revenues from fines and fees that should be accruing to the Commonwealth from the enforcement of state laws are not diverted, beyond a reasonable amount, by localities through the enforcement of parallel local ordinances. We have included language to establish a standard that when localities collect more than 30 percent of their total fines and fees from local ordinances, then one-half of the excess over 30 percent should be directed back to the Literary Fund.

I want to close by recognizing the outstanding work of our public safety, veterans affairs and homeland security agencies at both the state and local level. The men and women in adult and juvenile corrections, law enforcement, fire and emergency services, our forensic laboratories, the Virginia National Guard and the Air National Guard, and the Department of Veterans Services, deserve our sincere thanks for their dedication to public service and for their tireless efforts to keep all Virginians safe.

Mr. Chairman, this completes the report of your subcommittee.

Prevention Code for that designated use and occupancy. Such waiver shall not relieve the locality of the requirement for submission to and Board of Corrections approval of a community-based corrections plan, planning study, and construction of a permanent facility or enlargement. The community-based corrections plan and planning study for the permanent facility or enlargement shall be submitted to the Board of Corrections within twelve months of the approval by the Board of Corrections an annual update on the progress of the construction of a permanent facility or enlargement by July 1 of each year of the temporary facility's use. Failure of a locality to comply with the above requirements may result in the Board of Corrections terminating the locality's use of the temporary facility. Any locality receiving such a waiver shall not be eligible for construction funding reimbursement authorized pursuant to §§ 53.1-80 through 53.1-82, Code of Virginia, for the temporary facility."

Generally, maximum security cells, including isolation and segregation units, are counted as single occupancy cells. However, medium and minimum security cells, rooms, and dormitories may be designed to hold more than one inmate, including, for example, double, triple or quadruple occupancy cells or rooms, or dormitories in which double bunks are planned. The number of beds in these units should be counted in terms of planned multiple occupancy in the measurement of design capacity if the jail infrastructure is appropriately designed and adequate staffing is provided to accommodate the number of inmates anticipated in such multiple occupancy units.)

(This amendment reduces the total deposit into the Corrections Special Reserve Fund, as required under § 30-19.1:4, Code of Virginia, from \$12,128,309 in the budget as introduced to \$6,211,576, based on the adoption by the Senate of sentencing legislation which increases the required number of state-responsible correctional facility beds. Accordingly, this amendment captures a savings of \$5,916,733, relative to the budget as introduced. This amendment is contingent upon final passage of Senate Bills 66, 127, 159, 224, 273, 345, 431, 436, 459 and 486, and Senate Bill 503, which incorporated Senate Bill 138. A companion amendment in Part 2 of this act (Capital Outlay) creates a new Item C-33.1 to appropriate \$6.0 million from the Corrections Special Reserve Fund for the highest priority security-related capital improvement project for the Department of Corrections, consistent with the intent of § 30-19.1:4, Code of Virginia.)
