2016 Report of the Economic Development and Natural Resources Subcommittee The Honorable Frank M. Ruff, Jr., Chairman February 21, 2016

Chairman Hanger, Chairman Norment and Members of the Committee:

The work of your Economic Development and Natural Resources Subcommittee was driven by one guiding principle --fiscally responsible and prudent investment of public resources. Your subcommittee carefully reviewed the Governor's introduced budget for the Agriculture & Forestry, Commerce & Trade, and Natural Resources Secretariats. I am pleased to report that the subcommittee has made every effort to recommend investment in only those activities that we believe will grow Virginia markets and maintain our tradition of pursuing only the most cost-effective approaches to environmental stewardship.

In the area of Economic Development, we have devoted substantial resources to fostering private-sector growth and job creation. The budget we recommend to you contains \$121.9 million for economic development incentive payments for the biennium as as \$38.9 million to establish GO Virginia, well a truly transformational, business-led initiative that will provide state incentives to encourage effective regional collaboration among business, education, and government. However, realizing that the Finance Committee is facing many substantial challenges in other areas, our subcommittee analyzed proposals across all programs and identified significant savings that will be put to good use in other areas of the budget.

In the Department of Housing and Community Development, your subcommittee's actions reflect a commitment to helping

disadvantaged communities, particularly in rural and distressed urban areas of the Commonwealth. We propose increasing the Housing Trust Fund deposit to \$6.0 million in each year, an increase of \$2.0 million. Your subcommittee also recommends funding a pilot program to assess the effectiveness of an innovative approach for addressing the lack of healthy food options in underserved "food desert" communities. We also recommend an additional \$2.0 million for the Enterprise Zone program to attract business investment in areas of need, and we recommend additional resources to help fund water and wastewater projects in rural, low-income localities.

Tourism continues to be an important part of our economy and therefore we are endorsing an increase of \$1.0 million to expand the reach of our tourism marketing efforts. The budget will also provide \$8.0 million for the Motion Picture Opportunity Fund, an increase of \$1.6 million in each year, to continue the expansion of Virginia's successful and growing film industry.

In the Department of Agriculture and Consumer Services, we recommend a new initiative focused on growing Virginia farm businesses by providing farmers with business planning and market development tools to expand their reach within the state and around the world. Additionally, we endorse the Governor's proposal to increase funding to business incentives that are targeted directly at Agriculture and Forestry related industries.

In the area of Natural Resources, your subcommittee focused its efforts on identifying only the most cost-effective approaches toward meeting our obligations to improve the quality of waters in the Chesapeake Bay and the Southern Rivers. Therefore, we are recommending the full deposit of \$61.7 million to the Water Quality Improvement Fund. When combined with the \$77.0 million in bond proceeds proposed for investment in point and non-point source pollution reduction efforts, and an additional \$4.3 million in maintaining the infrastructure that supports public water supplies, a total investment of \$143.0 million is proposed for prudent investments in environmental stewardship. Let me be clear, as the long slow return to economic recovery continues, the subcommittee believes that significant additional public investment for the purchase of private land was not warranted. The cost per acre for these land acquisition programs does not provide a significant return on investment. As such, we recommend a significant reduction of \$10.0 million in each year in public funding for land acquisition and no funding for the purchase of any additional park land.

In closing, we believe our recommendations provide a balanced approach to move our economy forward while meeting our constitutional obligation to protect our vital natural resources.
