2015 Report of the Capital Outlay Subcommittee The Honorable Thomas K. Norment, Jr., Chairman February 21, 2016

Members of the Committee:

The Capital Outlay Subcommittee's primary focus this year has been on making long-term investments that are beneficial to the Commonwealth while using an appropriate level of our debt capacity. To that end, the recommended number of projects and dollars devoted to some areas of government decreased over what was in the introduced budget. This action was important in order to plan for the operating costs that these facilities will require in the future. Input from the relevant policy Subcommittees guided us on the best actions related to each area, and that advice has been incorporated in these recommendations. Additionally, Subcommittee members placed a high priority on properly maintaining existing facilities.

Based on these guiding principles, we initially incorporated many of our recommendations into SB 731, a bill that Senator Hanger and I patroned together. The bill included a capital construction pool of almost \$1.3 billion in VCBA/VPBA bond proceeds for 59 projects at higher education institutions and other state agencies. This is a reduction of more than \$345.0 million from the construction pool in the introduced budget. SB 731 further allocated \$39.0 million in bond proceeds for supplements to existing projects (an increase of \$2.0 million over the introduced budget), over \$13.0 million in bond proceeds for equipment for projects that are nearing completion, and \$59.0 million to reimburse localities for their investments in wastewater treatment.

The bill also referenced the \$16.0 million from the general fund that we have appropriated in the budget for project planning, down from \$20.0 million in the introduced budget. The Subcommittee recommends planning for a smaller number of projects in order to keep the future pool of construction projects at a manageable level. To the degree that we plan and construct additional facilities, operating costs will be required in the future.

I now wish to mention several of the major actions related to capital outlay that are reflected in the Subcommittee's amendments to the budget. First, the Subcommittee recommends \$65.0 million in bond proceeds for the Higher Education Research Initiative. As I mentioned in my earlier report, this initiative will focus on the commercialization of research through the recruitment of high performing researchers. These bonds will be used to renovate laboratory space and provide equipment for this purpose.

The second major item reflected in the budget relates to the bonds for the Port of Virginia for the enhancement of the Norfolk International Terminal. Here, the Subcommittee recommends \$215.0 million in VPBA bonds and \$135.0 million from existing transportation dollars. As this is a large investment in one project, we recommend reporting requirements to provide accountability before the project proceeds.

The Subcommittee also proposes \$20.0 million in bond proceeds in the first year for the Stormwater Local Assistance Fund in support of our continuing efforts to reduce non-point source pollution from stormwater runoff. This program provides matching grants to local governments for the implementation of stormwater projects, a cost-effective approach to reducing pollutants and improving water quality in the Chesapeake Bay Watershed.

The final item in the budget that I wish to mention is Maintenance Reserve funding. Preserving our existing facilities continues to be a top priority. For that reason, the Subcommittee recommends retaining the \$129.4 million from the general fund and the \$60.0 million in bond proceeds that were included in the introduced budget for this purpose. In addition, the Subcommittee has provided a supplement of \$1.0 million from the general fund for Maintenance Reserve funding for two of our higher education institutions in the second year that have high needs in this area.

In conclusion, the Capital Outlay Subcommittee has proposed a plan to continue strategic investments in multiple areas of the budget while prudently using our available debt capacity.

This completes the report of your Subcommittee and I hope it will be the pleasure of the committee to adopt our amendments.

Page 423, after line 26, insert:

"O. 1. All state entities, excluding the institutions of higher education governed under Chapters 675 and 685 of the 2009 Acts of Assembly, shall submit requests to use Design-build or Construction Management procurement methods, prior to proceeding with design, for new general fund supported construction projects, to the Department of General Services. The Department will review proposed construction procurement methods and make a decision on the appropriate method to be used. The method approved by the Department shall be carried out by the agency or institution of higher education. Approved projects and the approved procurement method shall be posted publicly on the Commonwealth's statewide electronic procurement system and program, eVA, at least 30 days prior to advertising for design services.

2. State entities, including institutions of higher education governed under Chapters 675 and 685 of the 2009 Acts of Assembly, with general fund supported projects already under a design contract may proceed with its selected procurement; however; the agency or institution will inform the Department of the procurement process selected, and comply with the posting requirements in this section for the construction procurement associated with such design.

3. The requirements of this section shall remain in effect until such time as the requirements of Chapters 776 and 760 of the 2015 Acts of Assembly, fourth and fifth enactment clauses are satisfied."

Explanation:

(This language only amendment requires state entities, including higher education institutions under Level I and Level II Restructuring, to receive approval from the Department of General Services prior to using Design-build and Construction Management procurement methods for new general fund supported construction projects. All state entities, including all higher education institutions, will report on existing general fund supported projects. This will provide appropriate oversight while completing the Construction procurement report required by Chapters 776 and 760 of the 2015 Acts of Assembly.)

Page 438, after line 11, insert:

"A. 1. A total of \$20,000,000 plus amounts to fund related issuance costs, and other financing expenses is hereby authorized for issuance in the first year by the Virginia Public Building Authority pursuant to § 2.2-2263, Code of Virginia for water quality projects as set out in this paragraph.

2. There is hereby appropriated \$20,000,000 in the first year from such bond proceeds, for the Stormwater Local Assistance Fund, established in Item 370 of this act and administered by the Department of Environmental Quality. In accordance with the purpose of the Fund, the bond proceeds shall be used to provide grants solely for capital projects, including: i) new stormwater best management practices; ii) stormwater best management practice retrofits; iii) stream restoration; iv) low impact development projects; v) buffer restoration; vi) pond retrofits; and vii) wetlands restoration. Such grants shall be in accordance with eligibility determinations made by the Department of Environmental Quality.

3. This appropriation is subject to the conditions in § 2-0 F of this act.

4. Except as provided for in paragraph A.3. of this item, the provisions of §§ 2.0 and 4-4.01 of this act and the provisions of § 2.2-1132, Code of Virginia, shall not apply to projects supported in the program."
