Madame Chair and Members of the Committee:

Your Subcommittee has reviewed the Governor's introduced budget for public education.

We are pleased to present a report that fully funds the Standards of Quality (SOQ) rebenchmarking. Overall, our recommendations provide an increase in Direct Aid to localities for Education of \$596 million in FY 2021 and \$738 million in FY 2022, above the FY 2020 levels - this totals \$1.3 billion over the biennium.

As you will recall, the introduced budget increased funding for the Virginia Preschool Initiative program by \$81 million, increased funding for at-risk students by \$57 million, and provided \$28 million for the state's share of additional instructors for limited English proficient students, which the Subcommittee recommends maintaining.

We suggest an additional \$48 million to increase the state's share of a teacher salary increase from 3.0 percent to 4.0 percent in the second year. We also recommend \$123 million for the state's share of a 3.0 percent bonus in the first year for teachers.

We propose \$40 million for additional school counselors, which funds the state's share of one school counselor for every 300 students in all public schools in the second year.

We have heard the concerns of members regarding the conditions of our school facilities. Therefore, we recommend \$27.5 million in each year to

restore the school construction grants program, which provides grants to all school divisions to assist with school construction, modernization of classroom equipment or debt service payments.

Other recommendations include almost \$600,000 to incentivize Allegheny and Covington schools to achieve economies of scale by operating as a joint division, and \$300,000 to support minority fellowships in early childhood classrooms.

The Subcommittee continues with its commitment to support and improve public education by devoting funding toward our teachers and investing in strategic ways to help our students succeed.

I thank the Subcommittee members and I look forward to continuing our on-going work regarding the future of K-12 education in the Commonwealth.
