# Report of the Subcommittee on Public Safety The Honorable Louise L. Lucas, Chair February 20, 2022

Madam Chair and Members of the Committee:

The Public Safety Subcommittee has reviewed the Governor's proposed budget for the agencies of Public Safety and Homeland Security and Veterans and Defense Affairs. Overall, the Subcommittee adopts many of the proposals in the introduced budget and recommends additional amendments that result in a net total of over \$70.0 million in general fund support for these agencies over the biennium.

A major focus of the Subcommittee was increasing compensation for public safety officers. Virginia's dedicated law enforcement officers have worked tirelessly amidst increasing recruitment and retention challenges. Addressing salaries and pay compression helps attract well-qualified candidates, furthers the goals of criminal justice reform, and fosters a positive environment for both the officers and those they serve. To that end, the Subcommittee recommends fully funding the compensation actions for sworn and correctional officers proposed in the introduced budget. The Subcommittee also recommends salary increases for probation and parole officers and Department of Juvenile Justice officers, as well as bonuses for non-security employees at the Department of Corrections. Finally, the Subcommittee endorses a historic increase of nearly \$50.0 million across three fiscal years for Virginia's Aid to Local Police Departments or "599" Program.

The Subcommittee recommends \$27.4 million over the biennium for a new Virginia Center for Firearm Violence Prevention and Intervention. Virginia's gun violence crisis requires a comprehensive response that



incorporates research, data collection, coordination, public awareness, and community-tailored interventions. The Subcommittee recommendation supports such a response, and includes \$10.0 million each year in grants for local initiatives led by community-based organizations, hospitals, and health, social services, and law enforcement agencies.

The Subcommittee continues its support for the Cannabis Control Authority as it establishes a retail cannabis market that prioritizes consumer safety and social equity. This recommendation includes the amount requested by the Authority to become fully operational. With passage of Senate Bill 391, significant additional fee and tax revenue will be dedicated to the Virginia Cannabis Equity Loan Fund. The Fund enables qualified social equity applicants, especially those harmed by prior criminalization of marijuana, to meaningfully participate in new cannabis business opportunities.

Additionally, the Subcommittee maintains its commitment to Virginia's veterans by adopting the proposals in the introduced budget for suicide and opiate use prevention, as well as additional service positions, at the Department of Veterans Services. Other Subcommittee recommendations include targeted investments in veterans housing and employment training, grants for Sexual Assault Forensic Examiners, and pre-trial and community corrections investments.

In closing, I would like to thank the members of the Public Safety Subcommittee for their collaboration and assistance in developing this report.

Madam Chair, this concludes the Public Safety Subcommittee report. I hope it will be the pleasure of the Committee to adopt our amendments.

#### **Explanation:**

(This amendment removes the general fund appropriation in fiscal year 2024 for the Virginia Cannabis Equity Business Loan Fund, which is no longer necessary due to significant additional revenue allocated to loans for qualified social equity applicants, pursuant to Senate Bill 391. Senate Bill 391 authorizes pharmaceutical processors and industrial hemp processors in Virginia to sell cannabis products to adults 21 years of age or older without a written certification, subject to certain requirements. It is estimated that this will result in at least \$24.0 million in additional revenue from fee and tax collections directed to Cannabis Control Authority loan funds beginning in fiscal year 2023. This reduction is contingent on passage of the provisions of Senate Bill 391 that provide additional revenue for social equity business loans.)

# **Explanation:**

(This amendment provides \$11.7 million from the general fund over the biennium for salary increases for probation and parole officers at the Department of Corrections. This amendment would increase the probation and parole officer starting salary to \$45,000

and increase supervisory salaries accordingly, addressing salary compression through the ranks. This compensation action was proposed by the Department of Corrections during the 2021 Public Safety Compensation Work Group.)

The amendment aligns with the minimum salary for correctional officers and the 5.0 percent increase each year for state employees included in the introduced budget.)

accordingly, in alignment with the compensation proposal for probation and parole officers at the Department of Corrections recommended during the 2021 Public Safety Compensation Work Group.)

### **Explanation:**

(This amendment provides \$3.1 million over the biennium from the general fund to increase salaries for residential specialists at the Department of Juvenile Justice. This amendment would increase the starting salary by 25 percent, adjust the minimum salary for supervisory staff accordingly, and provide "longevity" increases based on years of service. This amendment aligns with the compensation actions for Department of Corrections security staff included in the introduced budget.)
