2023 Report of the Higher Education Subcommittee The Honorable Mamie E. Locke, Chair February 5, 2023

Co-Chairs and Members of the Committee:

Your Subcommittee reviewed the Governor's proposed budget for Higher Education. The budget we adopted last year showed significant investments in our priority areas of affordability, access, completion, and workforce development.

Our Subcommittee recommendations continue to focus on these priority areas through increased investments in financial aid, institutional support, and workforce initiatives. In total, we propose an investment of \$279.1 million over the biennium. When you include the investments in Chapter 2, 2022 Special Session 1, the overall total for the biennium is \$1.13 billion.

To better assist our low- and middle-income students, the Subcommittee recommends an additional \$75.0 million in need-based financial aid and an additional \$25.0 million in a Pell initiative to attract and retain low-income students. Over time, our state financial aid has not kept up with the growth in tuition and fees. Higher education opens doors to a better quality of life and we want students and parents to know we are working to remove barriers to achieving a brighter future. Not only will this help individuals, but it also will help our communities and our Commonwealth.

To support our institutions, we recommend \$149.8 million in funding for operations. The Commonwealth has long had a goal to support twothirds of the costs of higher education for Virginia students. While recent investments have helped, we have lagged in achieving our goal. Today's investments will allow institutions to meet the growing need for student

support services; address increased costs resulting from inflation; refine or create programs that meet current and future workforce needs; and minimize the need to raise tuition and fees while moving us closer to that goal.

To address workforce needs, we know there are jobs that need to be filled in the Commonwealth which require a postsecondary credential. We also face critical shortages in certain areas, such as healthcare. As a result, we recommend \$25.0 million to invest in workforce programs at the community colleges; \$5.8 million to support nursing programs at our public institutions; and \$2.0 million to increase industry-based credentials through the New Economy Workforce Credential grant program.

Additionally, there are contingent allocations of \$100.0 million to continue to support access and affordability.

Finally, at the annual retreat in the fall, we heard about our declining population and potential impacts on higher education. We also know that we need to update our models to estimate costs and resource needs to better plan for enrollment changes. We propose to reconvene our Joint Subcommittee to focus on higher education costs, funding, performance, and enrollment planning to guide this effort. This Committee will build on the work of the State Council of Higher Education for Virginia, the recent recommendations by JLARC on financial aid and dual enrollment and other research to help us maintain our world-class system of higher education.

This concludes our report of the Higher Education Subcommittee and we hope it will be the pleasure of the Committee to adopt our amendments.

"A. Out of this appropriation, \$149,810,000 the second year from the general fund is provided to support operations at public colleges and universities. Funds are intended to support the growing need for student support services; address increased costs resulting from inflation; refine or create programs that meet current and future workforce needs; and minimize the need to raise tuition and fees. Funds shall be ongoing and shall be incorporated into the college's and university's base budget for the next biennium. The Department of Planning and Budget shall transfer the allocations to the appropriate education and general programs account as follows:

"A. Out of this appropriation, \$75,000,000 the second year from the general fund is provided to support need-based undergraduate financial aid at public colleges and universities. These funds also are intended to reduce the amount of tuition revenue from in-state undergraduate students that institution's use for financial aid, grants, and scholarships.

B. Of the amount allocated for undergraduate need-based financial aid in FY 2024 in this item and as part of the college's and university's budget, up to five percent may be used for emergency assistance programs for students facing a financial emergency that puts them at risk of dropping out. The Council shall establish reporting guidelines and approve criteria for making student awards.

C. Funds shall be ongoing and shall be incorporated into the college's and university's base budget for the next biennium. The Department of Planning and Budget shall transfer the allocations to the appropriate higher education student financial assistance account as follows:
